Additional details of the tour were discussed. It was decided that the tour would be moved to allow more of the commissioners to attend. Possible dates for the tour in November will be provided to the commissioners.

### **COUNTY POLICY ON TRAILS UPDATE**

Mrs. Davis stated she spoke with Terri Rahhal, Director of Planning. Ms. Rahhal provided the sections from the draft General Plan relevant to Regional Parks. The draft General Plan is out for public review. The sections were distributed to the Commissioners. The plan calls for looking at the current trails and improving on them moving forward. Mrs. Davis requested the Commissioners read over the material and respond to her directly via e-mail with any questions or comments regarding the plan by Wednesday. Mrs. Davis will forward the comments to Ms. Rahhal. Commissioner Ryan thanked Mrs. Davis. The Commissioners were happy to have the information.

### **PARK OVERVIEWS**

Mrs. Davis provided the following information to the Commission:

Currently working at each one of the parks to make sure the irrigation systems are operational.

Cucamonga Guasti pool is being evaluated for leaks.

Glen Helen – One slide is down. We are looking into repairing the slide for next season. The pool and one slide will be open for Nocturnal Wonderland, CALJAM and System of a Down events.

Yucaipa – Doggie Poolooza event was moved to Yucaipa from Cucamonga Guasti due to the pool being down. The event has gone very well. Dog adoptions were included in the event.

Several large events have been held at the parks. We are working to address trash issues at the parks after the large events.

### **Staffing Updates**

Administrative Supervisor interviews are continuing.

Park Superintendent (Yucaipa Regional Park) interviews should take place soon. This is a new position.

Assistant Park Superintendent position will begin advertising on Saturday.

A hiring event was held a couple of weeks ago. Fifteen General Services Worker positions were available. Ten General Services Worker positions were filled during the hiring event. Prado still has General Service Worker positions to fill. The hiring event

was very successful. The event speeds up the hiring process and allows staff to come on board faster.

**Prado Master Plan**

The consultant has interviewed staff and concessionaires at Prado. Community meetings will be scheduled. Mrs. Davis stated the commissioners will be invited to the community meetings to share in the process. An e-mail will be sent with the dates and locations of the community meetings.
