> The Regional Parks Administration office will be moving to the 3rd floor of 268 W. Hospitality Lane, in San Bernardino. The space will be available in July 2022. Mrs. Davis will provide additional information once the timeline and

relocation details have been finalized.

of Fish & Wildlife:

California Department • Representative Jeff Villepique gave a report on the status of the drought mitigation and stated this is the driest time period ever. He reported on the big

game guzzlers and the ramifications the drought is having on those. He also reported at this time their volunteer program has less members to help. The big horned sheep population in the area has been declining in the recent year due to lack of water and the respiratory disease in the herds. The situation is being monitored. He stated that these are challenging times for staff. Commissioner Olin stated that the Commission would be an available resource, if needed.

Unfinished Business:

- Future Federal Duck Stamp Events Commissioner Olin stated he had nothing to report today.
- The Wildlife Festival will be held on June 18, 2022, Commissioner Halbrook moves to have Chairman Richard and Vice Chair Frensonke reach out to and secure companies and vendors for the event rather than himself. Commissioner Franklin stated he also would also be involved in that. Mrs. Davis stated the new recreation coordinator would be starting soon. There will be a Fish and Wildlife Festival committee meeting within the next two weeks. At the next Commission meeting we will report back on the event.

New Business (Action Items)

 Representative Jeff Villepique gave a report of the ongoing sheep issue in Forest Falls. The Eldorado fire opened area up along the Valley of the Falls Road, and the sheep have more habitat, but also has led to them roaming and foraging along the highway. Signage warning vehicles has been placed. Their department has been working with Cal Trans. Chairman Richards thanked Jeff and his team for his work. Commission Franklin also thanked him for his report.

Open Comment/Discussion:

• Commissioner Olin stated that there has been an ongoing concern regarding coyotes. Calls from worried residents have increased. The commissioners and Jeff Villepique, Fish and Wildlife, discussed various strategies to handle the problem. He stated the urban coyote is frequently an issue in all states. Commissioner Halbrook stated he will look into ways of trapping the animals that pose a threat to the community's safety when they get to close and lose the fear of people. He will notify Fish and Wildlife of the areas that are a concern at this time. Commission Olin shared a video and pictures of the activity in his district to the members present at the meeting.
