5.0 **UNFINISHED BUSINESS**
TRAILS:

The updated trail signage with the Commissioner's recommendations from the January meeting were presented. The signage was unanimously approved. The Commissioners requested more information regarding the placement of the signage, which trails it would go on, and how many would go along the Santa Ana River Trail.

Ms. Stevenson notified the Commission that the California Department of Parks and Recreation, Division of Boating and Waterways will be conducting site visits, as part of the grant application review process, for the boat dock replacement at Cucamonga-Guasti, boater amenities at Lake Gregory and a boat dock acquisition at Mojave Narrows Regional Parks.

Ms. Stevenson discussed Kite Day with Supervisor Joe Baca, Jr. at Kessler Park. She stated it was a huge success. California Days is next weekend at Calico Regional Park as well as an Easter Celebration on Easter Sunday. A flyer for the lifeguard hiring was also provided to the Commission.

Commissioner Farrell stated he was planning on attending the Santa Ana River Trail Groundbreaking Ceremony, although was unable to make it.

Vice-Chair Jones inquired about the Deputy Director position. Mrs. Placencia explained second interviews were just completed. Ms. Stevenson informed the Commission that their updated photographs are on the Regional Parks website. Commissioner Farrell expressed his concern regarding the agenda's accessibility on the website. Mrs. Placencia stated she will inform Mrs. Davis about his concerns.
