Camp, Environmental Science Camp, No Bake Pie, Glow in the Dark Games, and the Easter. All the parks will have Easter egg hunts and Easter Bunnies to celebrate Easter. Bluegrass Festival is scheduled for May 13, 2023 at Calico Ghost Town Regional Park.

California Days at Calico Ghost Town Regional Park was extremely successful. Fishing with Supervisor Joe Baca, Jr. had over 100 children and their families in attendance for the fishing workshop.

Regional Parks Recreation Coordinator has submitted her resignation. The hiring process has started for her replacement.

Commissioner Mitchell stated he saw California Days on three different news channels before the event. Mrs. Davis explained Regional Parks' Communication Officer works closely with the Communication Department to assure the events are publicized.

Mrs. Davis went over the recent Board Agenda Items that were approved by the Board of Supervisors. This consisted of the Lineman's Rodeo for Prado Regional Park and sponsorship donations from mining companies and Raising Canes for California Days. Regional Parks is also working with the mining companies to update the museums at Calico Ghost Town. A Capital Improvement Project was approved for a Wi-Fi Project at Prado Regional Park. The items going before Board of Supervisor approval at the next meeting are a grant application for Coastal Conservancy for Santa Ana River Trail Section 4-A and approval to access funds for Glen Helen Amphitheater repairs.

Commissioner Kreeger inquired about the storm damages inside of the park. Mrs. Davis explained there are some damages at Lake Gregory Regional Park, but the assessments are not complete. Mrs. Davis will update the Commission at the April meeting.
