Commission Cox agreed with Commission Fresonke. Commissioner Franklin suggested that the funds stay with the Fish and Wildlife Festival to gain a baseline of monies for future years. Future Federal Duck Stamp Events

Commissioner Franklin has requested for the Federal Duck Stamp Event to be continued until he can speak with Commissioner Olin.

Grand Funding Request from The California Wild Sheep Foundation

This request was approved by the Board of Supervisors on October 25, 2022. Commissioner Franklin offered to contact the foundation and invite them to the next Commission meeting to present their documentation on how the grant funds were used. He is also going to obtain an invoice for the grant payment.

2023 Fish and Wildlife Festival

Vice Chair Fresonke discussed his contact with Bass Pro Shop and their willingness to be a long-term sponsor for the Fish and Wildlife Festival. Bass Pro Shop has verbally committed to provide at least \$5,000 for the 2023 Fish and Wildlife Festival and is contacting their corporate office to receive special permission to possibly fund \$25,000. Bass Pro Shop expressed their concerns regarding the date of the festival. Commissioner Fresonke stated it is his understanding that if the Fish and Wildlife Festival does not cost the complete \$25,000, it can be rolled over to future festivals.

Commissioner Fresonke stated this still requires a planning process with Regional Parks staff, Commission members, and Bass Pro Shop. This partnership will include positive promotions inside, and outside of the store as well as on their social media sites.

Commissioner Fresonke motioned to change the 2023 Fish and Wildlife Festival date from June 17, 2022, to June 10, 2022.

Jose Mendoza stated he will resubmit the funding request to the Commission after the changes are made.
