6.0 **DIRECTOR OF REGIONAL PARKS REPORT**

Deputy Director Jose Canedo was introduced to the Commission. He will present an overview of the maintenance plan at the November meeting.

Mrs. Davis went over staffing. A Staff Analyst II and a Naturalist recently started with Regional Parks. There are two more Naturalists, a Recreation Aide, a Recreation Coordinator, and two Park Rangers currently in the background process. Regional Parks is conducting interviews for an Assistant Superintendent at Mojave Narrows Regional Park and Public Service Employees for various parks.

Mrs. Davis presented an update of the El Prado Golf Course, which was previously requested by the Commission. The new owners of the Golf Course have kept the management team and are planning on multiple improvements. These improvements will be approved by the County prior to implementation. Mrs. Davis will update the Commission if there are major changes.

Mrs. Davis went over the Board Agenda Items that were approved by the Board of Supervisors. These Board Agenda Items included the approval of the Sabaidee Festival, the Solar Lighting Project at Glen Helen Regional Park, approval to Purchase Six Mobile Light Towers. The Capital Improvement Projects approved by the Board of Supervisors, included the Bridge Replacement and the Silver Bowl Project at Calico Ghost Town Regional Park, the Senior Center Roof Project at Lake Gregory Regional and the Splash Pad at Prado Regional Park. Additional funding was also approved for the Maintenance Shop-Electrical Repair Project located at Mojave Narrows Regional Park.

At the next Board of Supervisors meeting, Regional Parks is planning to submit the Glen Helen Master Plan and Marketing Study Contract as well as an MOU with Flood Control District for Maintenance on the Santa Ana River Trail for approval. On October 24, 2023, Regional Parks is planning to submit Capital Improvement Projects for the building that used to be Old Miner's Café and the stairs at Calico Ghost Town Regional Park to the Board of Supervisors for approval.

Mrs. Davis discussed the upcoming events occurring at the various parks. Calico Days at Calico Ghost Town Regional Park is from September 23-24, 2023, Harvest Festival at Mojave Narrows Regional Park is on October 7, 2023, and Calico Ghost Town Ghost Haunt is the last two weekends in October.

At this time, a conversation about the animals located throughout various parks was held. Commissioner Mitchell praised the Communications Officer for the available information on Regional Parks social media and website.

Commissioner Mitchell inquired about the contract with Live Nation. Mrs. Davis explained the current contract status, concert list, and traffic enforcement for these events.
