

**RELEASE AND HOLD HARMLESS AGREEMENT FOR
THE SAN BERNARDINO COUNTY
1-Day Trout Derby on January 10, 2026, at Prado Regional Park**

my participation at the 1-Day Trout Derby (hereafter referred to as "EVENT") may be hazardous and exposes me to the risk of personal injury, death, or property damage. I hereby acknowledge I am voluntarily participating in this EVENT and expressly agree to assume any such risks of injury or harm. I voluntarily assume full responsibility for any and all risks of injury, illness, death, or property damage arising out of or related to my participation in the Event, including before, during, and after the Event. I understand that as a voluntary participant, I am solely responsible for assessing my physical condition and skill level for participation and that I must follow all rules and instructions, including any equipment and safety requirements. I am responsible for my personal property and equipment. San Bernardino County is not responsible for loss, theft, or damage to personal property.

In consideration for being permitted to participate in the EVENT, I hereby release and forever discharge San Bernardino County, its officers, employees, agents, and volunteers for any personal injury, disability, death, or damage to or loss of personal property, arising out of or in connection with my participation in the EVENT, from whatever cause, including active or passive negligence of San Bernardino County, its officers, employees, agents, and volunteers or any other participants in the EVENT.

In further consideration of participating in the EVENT, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I will indemnify and hold harmless San Bernardino County, its officers, employees, agents, and volunteers from any and all claims, demands, actions, or suits arising out of or in connection with my participation in the EVENT brought by any third party.

I understand that California Civil Code Section 1542 provides: "A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in their favor at the time of executing the release, and that, if known by them, would have materially affected their settlement with the debtor or released party."

To the fullest extent permitted by law, I expressly waive the provisions of Section 1542 and any similar law of any jurisdiction with respect to the released claims and I understand and acknowledge the significance and consequences of this waiver. This waiver does not extend to claims that cannot lawfully be released.

I grant San Bernardino County a nonexclusive, royalty-free license to use my name, image, and likeness captured during the Event for Event-related promotional purposes in any media, without further notice or compensation.

I HAVE CAREFULLY READ THIS RELEASE AND HOLD HARMLESS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT IT IS A FULL RELEASE OF ALL LIABILITY AND SIGN IT OF MY OWN FREE WILL.
